RE: Notification No. SO 3350 (E) dated 28th September 2020 issued by the Central Government under Section 3(1) of the Unlawful Activities (prevention) Act, declaring the NSCN (K) of Nagaland, Manipur and Arunachal Pradesh as Unlawful Association. **The National Socialist Council of Nagaland (K).**

**SHOW-CAUSE NOTICE U/S 4(2) OF THE UNLAWFUL ACTIVITIES (PREVENTION) ACT.** Whereas the Central Government in exercise of the powers conferred by the Sub-section (1) of Section 3 of the Unlawful Activities (Prevention) Act 1967 (herein after referred to as "The Act" has declared the National Socialist Council of Nagaland (K) as Unlawful Association vide Notification No. SO 3350 (E) Dated 28th September 2020 published in the Gazette of India Extraordinary Part-II Section-3 -(iii).

AND WHEREAS BY THE Gazette Notification No. SO 3812 (E) dated 26<sup>th</sup> October 2020. (Published In the Gazette of India Extra ordinary part-II section-3, Sub Section- (II)] in exercise of the powers under Section-5(1) of the Act, the Central Government has Constituted Unlawful Activities (Prevention) Tribunal comprising Hon'ble Mr. Justice Kalyan Rai Surana, Judge, Gauhati High Court, for adjudicating whether or not there is sufficient cause for declaring the NSCN (K) as Unlawful Association as referred by Section-(1) of Section -4 of the Unlawful Activities (Prevention) Act 1967.

NOW THEREFORE a notice is hereby given to you under sub-section-(2) of Section-4 of the Act and you are hereby called upon to show cause in writing within 30 days from the date of service of this notice as to why your association should not be declared as Unlawful and why order should not be made confirming the declaration made in the above mentioned Notification.

The objection/reply/written statement if any may be filed/delivered within the statutory period of 30 days from the service, to the undersigned at her Office Chamber of the Principal District and Sessions Judge, Dimapur. In case objections/reply/written statements and documents are in regional language, their English translation be also attached.

You are required to appear before the Tribunal on 26-03-2021 at 10:30 AM venue will be initiated at a later date.

Appearance can also be caused through a duly authorized and instructed Counsel/Advocate.
